General Expectations

<u>Pioneer High School</u> agrees to implement the following statutory requirements:

- Consistent with section 1118, the school will work to ensure that the required school level parental involvement policies meet the requirements of section 1118 of the ESEA, and each include, as a component, a school-parent compact consistent with section 1118(d) of the ESEA.

The school will convene the meeting at a time convenient for parents and will offer a flexible number of additional parent meetings, such as in the morning or evening, so that as many parents as possible are able to attend. - 4. <u>Pioneer High School</u> will provide parents of participating children information in a timely manner about Title I, Part A programs that includes a description and explanation of the school's curriculum, the forms of academic assessment used to measure children's progress, and the proficiency levels students are expected to meet by:
 - Coordinating campus visits prior to enrollment
 - Coordinating meetings with parents and students to ensure a smooth transition
 - Providing early college/university preparation materials for parents and students (Go Center – Melinda Zuniga)

- 5. <u>Pioneer High School</u> will at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible by:
 - Parent meeting with School Principal, Parent Engagement Specialist and Community Liaison to review parent suggestions.
- 6. <u>Pioneer High School</u> will provide each parent an individual student report about the performance of their child on the State assessment in at least math, language arts and reading by:
 - House mail
 - E mail
 - Conduct teacher-parent-student meetings
- 7. <u>Pioneer High School</u> will take the following actions to provide each parent a timely notice when their child has been assigned or has been taught for four or more consecutive weeks by a teacher who is not highly qualified within the meaning of the term in section 200.56 of the Title I Final Regulations (67 Fed. Reg. 71710, December 2, 2002) by:
 - Mailing notice out
 - Skyward message to parents
 - E mail to parents
- 8. **Pioneer High School** will provide assistance to parents of children served by the school in understanding the following topics:

 - State's and local academic assessments including alternate assessments.

 - How to monitor their child's progress, and
 - How to work with educators:
 - TACRO Day

- 9. <u>Pioneer High School</u> will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parental involvement, by:

 - English (as a second language) classes
